**BOYD RANCH COMMUNITY EQUITATION AND NATURE PARK  
EVENT WAIVER AND RELEASE OF LIABILITY**

BY SIGNING THIS AGREEMENT, YOU ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGES IN CASE OF INJURY, DEATH OR PROPERTY DAMAGE. READ THIS AGREEMENT CAREFULLY BEFORE SIGNING IT. YOUR SIGNATURE INDICATES YOUR UNDERSTANDING AND AGREEMENT TO ITS TERMS.

This is an agreement between the Undersigned, The Boyd Ranch Community Equestrian and Nature Park, (dba Boyd Ranch), and their owners, officers, directors, members, managers, employees, agents, representatives, volunteers, sponsors, sanctioning organizations, affiliates, partners, joint venturers, successors and any and all other persons or entities otherwise involved with organizing or putting on the Event (collectively, the "Releasees").

I, \_\_\_\_\_ (hereinafter the "Undersigned") on behalf of myself, my personal representatives, heirs, next-of-kin, spouse and assigns HEREBY:

All attendants are voluntarily participating in the event and are participating in this event at their own risk. I agree to indemnify and hold harmless the Boyd Ranch against any and all claims, suits or actions of any kind whatsoever for liability, damages, compensation or otherwise brought on by me or anyone on my behalf, including attorney's fees and any related costs, if litigation arises pursuant to any claims made by me or by anyone else acting on my behalf.

1. I Agree to abide by and follow any instructions given or rules established by Releasees or any of their employees, agents or volunteers with regard to my participation in any event. I am aware there are risks at the Ranch and surrounding which would include, but not limited to, those caused by terrain, facilities, temperature, weather, lack of hydration, condition of participants, vehicular traffic and actions of others including, but not limited to, participants, volunteers, staff, event officials and or/producers of the event.
2. The Undersigned expressly agrees that the foregoing release and waiver of liability, assumption of risk and indemnity agreement is governed by the State of Arizona and it is intended to be as broad and inclusive as is permitted by Arizona law, and that in the event any portion of this Agreement is determined to be invalid, illegal, or unenforceable, the validity, legality and enforceability of the balance of the Agreement shall not be affected or impaired in any way and shall continue in full legal force and effect.
3. I Acknowledge that this document is a contract and agree that if a lawsuit is filed against any of the Releasees for any injury or damage in breach of this contract, the Undersigned will pay all attorneys' fees and costs incurred by the Releasees in defending such an action.
4. I agree to leave the Boyd Ranch in the condition it was upon arrival. Including returning any set up equipment, chairs table, to their original location. All garbage and trash will be removed as well as personal decorations and belongings. Charges may be made against my security deposit for any damages or need to employ staff to return the Boyd Ranch to its original state. I will be responsible for any damages incurred to the facility or equipment. and any moneys needed to repair.
5. THIS RELEASE AND WAIVER OF LIABILITY IS VALID IN PERPETUITY AND APPLIES TO ALL ACTIVITIES ASSOCIATED WITH THE EVENT. I HAVE READ THIS DOCUMENT. I UNDERSTAND IT IS A PROMISE NOT TO SUE AND A RELEASE AND INDEMNITY FOR ALL CLAIMS By signing this waiver, I agree that should myself or my heirs pursue a law suit against the Boyd Ranch, any of it events, employees or volunteers that I agree to pay all Boyd Ranch legal fees and court costs incurred in the suit up to and including court costs, attorney fees and any judgement against the Boyd Ranch, employees, and volunteers

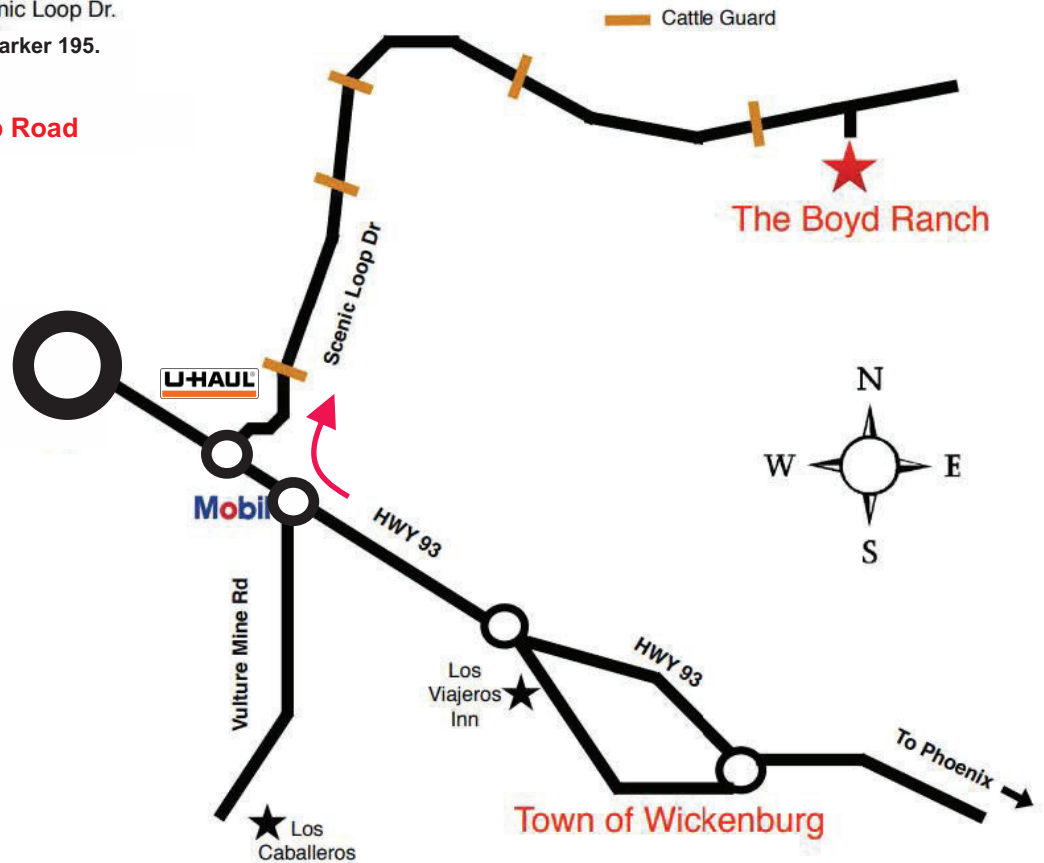


## DIRECTIONS FROM WICKENBURG

- \* Head NW on Highway 93 towards Las Vegas
- \* Look for a Mobile gas station. Drive exactly one mile past the Mobile and turn right on Scenic Loop Dr.
- \* Scenic Loop Road is next to Mile Marker 195.
- \* UHAUL is on the corner.

### Once you turn onto Scenic Loop Road

- \* Stay on this road for 8.5 miles
- \* You will go over 5 cattle guards
- \* Follow signs to The Boyd Ranch
- \* Ranch will be on your right
- \* This is a dirt road - expect a slower speed and about 30 to 35 minutes of driving time once you turn off of HWY 93.
